



**INVITATION TO RE-BID**  
**SUPPLY AND DELIVERY OF MINI-EXCAVATOR**

1. The Bureau of Soils and Water Management, through the “**General Appropriations Act**” intends to apply the sum of **One Million Three Hundred Seventy Thousand Pesos (P1,370,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of Mini-Excavator**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Bureau of Soils and Water Management now invites the to bid for the hereunder project:

**Name of Project:** Contract for the Supply and Delivery of Mini-Excavator  
**Location of Bidding:** Bureau of Soils and Water Management, SRDC Bldg., Q.C.  
**Place of Delivery:** San Ildefonso, Bulacan

2. Delivery of the GOODS is required 30 calendar days after the issuance of the Notice to Proceed. Bidders should have completed, within the last two years [2017-2018] from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
  3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
- Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from BSWM-BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 am to 5:00pm.
  5. A complete set of Bidding Documents may be purchased by interested Bidders from **February 25, 2019 to March 20, 2019, 9:30AM** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P1,300.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The BSWM-BAC will hold a Pre-Bid Conference on **March 05, 2019 9:30AM** at **BSWM Lecture Room 2, SRDC Bldg. Elliptical Road corner Visayas Avenue, Diliman, Quezon City**, which shall be open to all prospective bidder.

7. Bids must be received by the BAC Secretariat to the address below on or before **March 20, 2019 at 9:30am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **March 20, 2019 at 9:30am** at the **BSWM Lecture Room 2, SRDC Bldg. Elliptical Road corner Visayas Avenue, Diliman, Quezon City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
