CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of JAN 10 2023 20____ between **Bureau of Soils and Water Management** of SRDC Building, Visayas Ave. corner Elliptical Road, Diliman, Quezon City, Philippines herein represented by its Director, **GINA P. NILO, Ph. D.** (hereinafter called "the Entity") of the one part and **Urduja Security Services, Inc.** of 138 Matalaya, Lingayen, Pangasinan herein represented by its President, **NEPTHALIE D. PASILIAO** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROCUREMENT OF BSWM SECURITY SERVICES FOR CY 2023- IB NO.: BSWM 2023-00-002** procured through **Public Bidding** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Eight Million Nine Hundred Seventy- Five Thousand Eight Hundred Ninety-Five and 28/100 Pesos only (PhP 8,975,895.28)** covering the period of **January 16- December 31, 2023** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conformed thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such
