CONTRACT AGREEMENT

THIS AGREEMENT made this JAN day of 023 20 between Bureau of Soils and Water Management of SRDC Building, Visayas Ave. corner Elliptical Road, Diliman, Quezon City, Philippines herein represented by its Director, GINA P. NILO, Ph. D. (hereinafter called "the Entity") of the one part and Apex Office Supplies and Equipment Trading of Unit 202, Tara Residence Condominium, 398 Tandang Sora Ave. Brgy.
