**CONTRACT AGREEMENT**

THIS AGREEMENT made this            day of JAN 09 2023 20 between **Bureau of Soils and Water Management** of SRDC Building, Visayas Ave. corner Elliptical Road, Diliman, Quezon City, Philippines herein represented by its Director, **GINA P. NILO, Ph. D.** (hereinafter called "the Entity") of the one part and **NAFC-DA Multi-Purpose Cooperative** of Elliptical Road, Diliman, Quezon City, herein represented by its Chairperson, **JOSE REDENTOR H. BESENIO** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROVISION OF BSWM IN-HOUSE CATERING SERVICES FOR FY 2023-IB NO.: BSWM 2023-00-012** procured through **Public Bidding** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Million Two Hundred Eighty-Six Thousand Three Hundred Eighty Pesos (Php 4,286,380.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conformed thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such
