We are pleased to inform you that your bid dated December 3, 2024 for the execution of the contract for the Re-bid of Construction of Hazardous Waste Storage and Materials Recovery Facility for BSWM Central Office- IB No. BSWM 2024-10-068 with a Contract Price equivalent to Two Million Six Hundred Ninety Five Thousand Seven Hundred Seventy One and 17/100 Pesos (PhP 2,695,771.17) undertaken through Public Bidding being the Single Calculated and Responsive Bid (SCRB) has been accepted.

Pursuant to Section 39.1 of the Implementing Rules and Regulations of Republic Act 9184, you are hereby required to **provide within ten (10) calendar days** from the receipt of this notice, **a Performance Security** and **signed Contract Agreement**. (c) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security. Together with the surety bond, a copy of a valid Certification from Insurance Commission must be	Thirty percent (30%)





submitted by the bidder which must state that the surety or the insurance company is specifically authorized to issue surety bond.

Failure to provide and comply with the above-mentioned requirement shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security.
