INVITATION TO BID FOR

Procurement of Supply and Delivery of 371 Units of Composting Facility for Biodegradable Wastes (CFBW) for CY 2021 (IB No. BSWM 2021-02-017)

- 1. The BUREAU OF SOILS AND WATER MANAGEMENT, through the GENERAL APPROPRIATION ACT FOR CY 2021, intends to apply the sum of THREE HUNDRED FIFTY-TWO MILLION FOUR HUNDRED FIFTY THOUSAND PESOS (PHP 352,450,000.00) being the ABC to payments under the contract for PROCUREMENT OF SUPPLY AND DELIVERY OF 371 UNITS COMPOSTING FACILITY FOR BIODEGRADABLE WASTES (CFBW) FOR CY 2021 (IB NO. BSWM-2021-02-017). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The BUREAU OF SOILS AND WATER MANAGEMENT now invites bids for the procurement of the above Procurement Project Delivery of the Goods is required by **DECEMBER 31, 2021**. Bidders should have completed, within FIVE (5) CONSECUTIVE YEARS from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from BUREAU OF SOILS AND WATER MANAGEMENT and inspect the Bidding Documents at the address given below during OFFICE HOURS MONDAY TO FRIDAY, 8:00AM TO 5:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on FEBRUARY 26, 2021 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIFTY THOUSAND PESOS (PHP 50,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person if paid through BSWM Cashier; or through facsimile or electronic means if paid through bank to bank transaction.

- 6. The BUREAU OF SOILS AND WATER MANAGEMENT will hold a Pre-Bid Conference on MARCH 4, 2021, 9:30AM at BSWM CONVENTION HALL, QUEZON CITY and through video conferencing or webcasting via ZOOM, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through manual submission at the
 office address indicated below, on or before MARCH 18, 2021, 9:00AM. Late bids
 shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on *MARCH 18, 2021, 9:30AM* at the given address below and via *ZOOM*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The above-mentioned schedules can be subject to change due to the Community Quarantine enforced by the government in line with the COVID-19 pandemic. Please refer to the BSWM PhilGEPS posting and BSWM Procurement Service Facebook Page for updates.

During the opening of bids, Bidder's representative must present his/her Company Identification Card and Authorization Letter from the Head of the Company.

- 11. The BUREAU OF SOILS AND WATER MANAGEMENT reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
