We are pleased to inform you that your bid dated December 10, 2024 for the execution of the contract for the **Re-bid of Lot 2 for the Supply and Delivery of various items for CY 2024-IB No. BSWM 2024-11-070** with a Contract Price equivalent to **One Million Four Hundred Thousand Pesos (Php 1,400,000.00)** undertaken through Public Bidding being the **Single Calculated and Responsive Bid (SCRB)** has been **accepted**.

The Performance Security shall be denominated in Philippine Pesos and posted in favor of the Procuring Entity in an amount not less than the required percentage of the total contract price in accordance with the following schedule:

(b) Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank.	Five percent (5%)
(c) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security. <u>Together with the surety bond, a copy of a valid Certification from</u>	Thirty percent (30%)



<u>Insurance Commission must be submitted by the bidder which must state that the surety or the insurance company is specifically authorized to issue surety bond.</u>
