Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- Other contract documents that may be required by existing laws and/or the V. Procuring Entity concerned in the PBDs. - The Bureau of Soils and Water Management agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
