We are pleased to inform you that your bid dated August 27, 2024 for the execution of the contract for the **Procurement of 16 units of Mobile Soil Laboratory for CY 2024- IB NO: BSWM-2024-07-046 Lot 1 (Php 143,156,000.00), Lot 3 (Php 155,156,000.00) and Lot 4 (Php 171,156,000.00)** with a total Contract Price equivalent to **Four Hundred Sixty Nine Million Four Hundred Sixty Eight Thousand Pesos (Php 469,468,000.00)** undertaken through Public Bidding being the **Lowest Calculated and Responsive Bid (LCRB) for Lots 1 and 3 and Single Calculated and Responsive Bid (SCRB) for Lot 4** has been accepted.

(c) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security. <u>Together with the surety bond, a copy of a valid Certification from Insurance Commission must be submitted by the bidder which must state that the surety or the insurance</u>	Thirty percent (30%)




Failure to provide and comply with the above-mentioned requirement shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security.
