(c) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security. <u>Together with the surety bond</u> , <u>a copy of a valid Certification from</u> <u>Insurance Commission must be</u> submitted by the bidder which must state	Thirty percent (30%)



that the surety or the insurance company	
is specifically authorized to issue surety	
bond.	

Failure to provide and comply with the above-mentioned requirement shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security.
