**CONTRACT AGREEMENT**

THIS AGREEMENT made the \_\_\_\_\_ day of MAY 24 2024 between **Bureau of Soils and Water Management** of SRDC Building, Visayas Ave, corner Elliptical Road, Diliman, Quezon City, Philippines (hereinafter called "the Entity") of the one part and **Project Management & Technical Resources Corporation** of G/F-2F Bldg. 3 Uptown Corporate Center, Melchora Aquino Cor. JP Rizal St., Rizal Technopark Highway 2000, San Juan, 1920 Taytay, Rizal (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply, Delivery and Installation of File Compactor for BSWM Personnel Section Office for CY 2024 - IB No. BSWM 2024-03-034** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Hundred Fifty-Six Thousand Eight Hundred Eighty-Eight Pesos (PhP 356,888.00)** (hereinafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **Three Hundred Fifty-Six Thousand Eight Hundred Eighty-Eight Pesos (PhP 356,888.00)** or such other sums as may be ascertained, **PROJECT MANAGEMENT & TECHNICAL RESOURCES CORPORATION** agrees to the **Supply, Delivery and Installation of File Compactor for BSWM Personnel Section Office for CY 2024 - IB No. BSWM 2024-03-034** in accordance with his/her/its Bid.
