

### Contract Agreement Form for the Procurement of Goods (Revised)

#### CONTRACT AGREEMENT

**THIS AGREEMENT** made the 25th day of April 2024 between **Bureau of Soils and Water Management** of SRDC Building, Visayas Ave. corner Elliptical Road, Diliman, Quezon City, Philippines (hereinafter called "the Entity") of the one part and **VJ Graphic Arts, Inc.** of Unit 12 No Future Point Plaza 2, 115 Mother Ignacia Ave., Diliman, Quezon City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Provision for Layout Design, Printing, and Binding Services for BSWM related IEC Materials for CY 2024- IB NO: BSWM-2024-02-030** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Three Hundred Thirty Six Thousand Seven Hundred Seventy Five Pesos (Php 1,336,775.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

  - iv. General and Special Conditions of Contract; and
  - v. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **One Million Three Hundred Thirty Six Thousand Seven Hundred Seventy Five Pesos (Php 1,336,775.00)** or such other sums as may be ascertained, **VJ Graphic Arts, Inc.** agrees to **Provision for Layout Design, Printing, and Binding Services for BSWM related IEC Materials for CY 2024- IB NO: BSWM-2024-02-030** in accordance with his/her/its Bid.
4. **The Bureau of Soils and Water Management** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
