CONTRACT AGREEMENT

THIS AGREEMENT made this MAR 18 2021 day of 20 between **Bureau of Soils and Water Management** of SRDC Building, Visayas Ave. corner Elliptical road, Diliman, Quezon City, Philippines herein represented by its Officer-In-Charge, Director, **SONIA M. SALGUERO** (hereinafter called "the Entity") of the one part and **Exotherm Inc.** of Unit S-10 Daniel Commercial Complex National Hi-way Brgy. Parian City, Calamba, Laguna herein represented by its President and CEO, **FRANCIS S. RAMOS** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PREVENTIVE MAINTENANCE OF THE SUBMERGE MEMBRANE BIOREACTOR (SMBR) for CY 2021- IB NO. BSWM 2021-01-009** procured through **Public Bidding** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million Four Hundred Sixty-One Thousand Six Pesos (Php 2,461,006.00)** (hereinafter called "the Contract Price").

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conformed thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
