CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of APR 29 2021 20____ between **Bureau of Soils and Water Management** of SRDC Building, Visayas Ave. corner Elliptical road, Diliman, Quezon City, Philippines herein represented by its Officer-In-Charge, Director, **SONIA M. SALGUERO** (hereinafter called "the Entity") of the one part and **RU Foundry and Machine Shop Corporation** of Sitio Aning, Barangay Pahanocoy, Bacolod City, Negros Occidental, herein represented by Vice President, **MARIA RAMONA S. UY** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **SUPPLY AND DELIVERY OF 61 UNITS OF SMALL-SCALE COMPOSTING FACILITY (SSCF) FOR CY 2021 -IB NO. BSWM 2021-02-016** procured through **Public Bidding** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Twenty-Seven Million Four Hundred Thirty-Three Thousand Two Hundred Eighty Pesos (Php 27,433,280.00)** (hereinafter called "the Contract Price").

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conformed thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such
