CONTRACT AGREEMENT

THIS AGREEMENT made this MAY 14 day of 2021 20 between **Bureau of Soils and Water Management** of SRDC Building, Visayas Ave. corner Elliptical road, Diliman, Quezon City, Philippines herein represented by its Officer-In-Charge, Director, **SONIA M. SALGUERO** (hereinafter called "the Entity") of the one part and **Quartz Business Products Corporation** of 15th Floor Capital House 9th Ave. corner 34th St. Bonifacio Global City, Taguig City herein represented by its Account Manager, **JERVIN F. 
NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conformed thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such

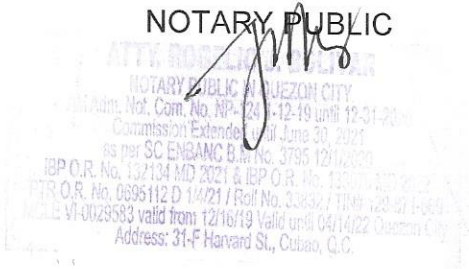
