WHEREAS, based on the results of the Post Qualification evaluation conducted with the assistance of TWG and End-Used held last October 11, 2021, the members of the Committee found it reasonable to recommend the award for SUPPLY AND DELIVERY OF TECHNOLOGY PACKAGE ON COMPOSTING FACILITY FOR BIODEGRADABLE WASTES (CFBW) BATCH 2 -IB NO.: BSWM 2021-08-034 to AIMS AGRI VENTURE, INC. with a contract price equivalent to Ninety-One Million Two Hundred Twenty-Four Thousand pesos (Php 91,224,000.00) as the Lowest Calculated and Responsive Bid (LCRB) under Section 34.4 of the Republic Act 9184 also known as the Government Procurement Reform Act (GPRA) and its Revised Implementing Rules and Regulations, to wit:

"Section 34.4. If the **BAC** determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower."
